

The Virginia State Land Tax, from 1782 on

When in the fall of 1781, the Virginia Assembly undertook to create a taxing regime for the fledgling state, and to retire its Revolutionary War debts and those of the national confederation of which it was one of the leaders, it initiated a statewide land tax with the following simple language:

And be it farther enacted, That there shall be collected, paid and distrained, for the tax of one pound for every hundred pounds, and so in proportion for every greater or lesser sum, of the valuation of all lands and lots, as the same shall be returned by the commissioners to the clerk of each county within this commonwealth; {*Hening's Statutes* 10:504}

In Oct1782, "An act for equalizing the land tax" {*Hening's Statutes* 10:140-145 } clarified the respective roles of the new tax commissioners, the county clerk, and the sheriff, and in further legislation in 1786 {at *Hening's* 12:245-146} the duty of the commissioners to note changes of ownership was made explicit. Later, for the year 1813, the commissioners were further directed to include a differentiating description of the land, and finally, for 1814 and beyond, they were required to note its distance direction from the courthouse, and to record whether the title holder of the land was a resident of the county or not.

Abstracting Conventions

The lists from 1782-1788 are spotty, but are essentially complete from 1789 on, except for 1808 when no tax was assessed. Each year there were two lists, corresponding to Districts 1 and 2, and I have created separate headings for each, for example "1812-List2". List titling is sporadic and inconsistent, although most lists bear dates which are intrinsic, or are found on apparently associated pages.

Although I have rearranged the fields somewhat, and created my own columnar headings, all the text abstracted below is literal, except for my interpolations [within square brackets], which I have used primarily to expanded unproblematic abbreviations, including those of names. All names below also appear in inverted order (surname, given name(s)), which the way that most of them appear in the original

The only data missing from these abstracts are the valuations and the tax rates, but these are available from the complete set of images available with this report.

The "Residence" field (headed "RES?") which begins to appear in the 1814 list, was usually filled in as either "resident" or "non-resident". I have abstracted the latter as "NON", or rendered the literal text if a place of non-residence was indicated, but I have otherwise left this field blank in my abstracts except trhat where a non-resident entry is expected but missing, I have entered "---" in the field.

Many landholders owned several tracts, and in 1813 the tax lists began to identify each by location(distance and direction from the courthouse) and by description. Usually a man's several tracts were in the same location, and even contiguous so it became expedient to ditto these fields. Instead of using the ditto marks we are familiar with, the BuckinghamCo clerks drew horizontal lines through the dittoed fields. I have indicated dittoing by entering the dittoed contents of these fields within square brackets.

Where text is illegible due to poor writing, filming, or document damage, I have entered "*" for each character. Fractions of acreas are rendered as decimal fractions.
